FAMILY VIOLENCE

"**Family violence**" means "an act by a member of a family or household against another member of the family or household that is intended to result in physical harm, bodily injury, assault, or sexual assault or that is a threat that reasonably places the member in fear of imminent physical harm, bodily injury, assault, or sexual assault, but does not include defensive measures to protect oneself " Tex. Fam. Code, sec. 7.004."**Bodily injury**" means physical pain, illness, or any



impairment of physical condition. Tex. Penal Code, sec. 1.07(a)(18). Note: Controlling behavior and verbal abuse (name calling) is not "violence".
